The State Water Harvesting Mission Steering Committee will:-

- 1) Function as the general body of the Mission.
- 2) Comprise of all the founding Members and other Members with Chief Secretary of the State as the Chairperson.
- 3) Be responsible for broad policy guidelines.

Terms of Reference :-

- 1) Supervise and control the affairs and funds of the Mission.
- 2) Receive funds from the Central Govt./State Govt./other Funding Agencies and maintain Accounts thereof.
- 3) Scrutinize and accord administrative, technical and financial approval to projects within the purview of the Mission and within the approved Budget.
- 4) Clearance of schemes/projects would be deemed to have the approval and concurrence from Planning and Finance Department based on which the Planning Department in consultation with Finance Department may consider bulk sanctions and release of funds.
- 5) On approval of the schemes, the Mission Director will submit the demands for release of funds to the Mission Executive in Planning Department and funds will be released to the Mission Director with the approval of the State Water Harvesting Mission Steering Committee
