2. The Council may co-opt any other/ expert member as and when required.
3. The Board shall advise the Government of Meghalaya on the following –
 - a) To identify the infrastructural gaps in the State;
 - b) To promote Meghalaya as an investment destination;
 - c) To identify and co-ordinate all measures to improve the State's ranking in the Ease of Doing Business along with monitoring of such measures;
 - d) To identify different sources of funding for implementation of major projects in the State including the possibility of PPP based funding;
 - e) To co-ordinate and facilitate all relevant matters so as to fast track realization of such investment opportunities.
 - f) To supervise the function of the Programme Management Unit which shall be created to provide the necessary support for investment promotion in the State.
4. The Governing Council shall meet at least once in every quarter.
5. The Executive Chairman shall be responsible for the day-to-day functioning of the Board.
6. The Administrative Department to service the Board is the Planning Department.
