Terms of Reference:

1. The Cell will be responsible to address the issues raised by any aggrieved person who are not satisfied with the verdict of the Grievance Redressal Mechanism Cell Tier I pertaining to social or/and environmental issues with respect to the ADB assisted project SHCDM - II.
2. The Cell is required to provide its view within 7 working days of the receiving of grievance.
3. Reach mutually agreed solutions satisfactory to both the project and the affected person including scheduled tribes and resolve any project-related grievance locally, in consultation with the aggrieved party.
4. Facilitate the smooth implementation of the social and environmental plan and prevent delay in project implementation.
5. Democratize the development process at the local level, while maintaining transparency and establishing accountability to the scheduled tribes.
6. Facilitate effective dialogue and open communication between the project stakeholders
7. Clearly define the roles and responsibilities of the various parties involved in the consideration and resolution of grievances
