Subject: Modified Standing Instructions regarding sanction and implementation of Plan Schemes from the year 2010-11 onwards.

Sir,

In continuation to this Department's circular No. PLR. 35/1997/Pt/40 dated 30-08-2011 relating to the above mentioned subject, I am directed to say that the last date for **sanctioning of the schemes/ proposals under the Delegation of Financial Power Rules under Plan** has been further extended to the **31st October, 2011**.

Further, in respect of the Plan proposals/ schemes which have been cleared/ approved by the Empowered Sanctioning Committee, you are requested to issue sanctions in accordance with the decisions recorded in the minutes circulated by Planning Department from time to time. The approval of the Empowered Sanctioning Committee in respect of proposals involving re-appropriation of funds are also to be further submitted to Finance Department for obtaining their signature in the Re-appropriation Statements.

It is reiterated that the funds for which sanctions are not issued under Delegation of Financial Powers or with approval of Empowered Sanctioning Committee within the 31st |October, 2011, will be considered for diversion to other sectors where additional investments are deemed necessary. It is also clarified that the time limit of 31st October, 2011 for sanctions under Delegation of Financial Powers is applicable only to Plan Schemes. Further, once the Plan Schemes have been sanctioned by the Empowered Sanctioning Committee, there would be no time limit for subsidiary sanctions issued under the DFP Rules.
