- This proposed centre for Indigenous Research is a long cherished dream of Meghalaya's first Padmashree recipient (L) Smti Sitimon Sawian. Her family and predecessors were actively involved in the promotion and preservation of the local culture, heritage and traditions of the Khasis in these hills more so, since the advent of the British colonists to these Hills.
 - 1.2. She and her forefathers' including her other family members were involved in documentation and publication of writings on the ancient culture, music, folk tales/ folklore etc and heritage of the Khasi people. This opened the way for other scholars and writers to follow suit to engage in this endeavour. This has resulted in the generation of vast collection materials such as books and publications on literature, history, cultural and religious practises along with studies on traditional medical practices etc of the Khasis as a race. This material in turn continues to be passed down to the present generation of scholars and writers.
 - 1.3. In her quest to realise her dreams, she assembled a team of educated and well qualified members from The Seng Khasi Nongthymmai Madanrting Pyllun and entrusted them with the task of planning, management and the responsibility of running the future operations of this proposed Centre.
