Secretary, NEC in exercise of the financial powers delegated by the Govt. of India, Ministry of DoNER vide letter No. 4/1/2010-DoNER (NEC) dated 7th September, 2012 has accorded Administrative Approval for "**Construction of Khadi Plaza/Market Complex of Meghalaya Khadi & Village Industries Board at Barik Point, Shillong**" at an estimated cost of Rs. 2.737685 cr (Rupees two crore seventy three lakhs seventy six thousands six hundred and eighty five only) only implemented by the **Directorate of Commerce & Industries, Government of Meghalaya** to be funded by NEC under "**Scheme of North Eastern Council**" MH- 2552, OH - 35.



12. This issued with the concurrence of Integrated Finance with vide their Dy. No. **351** dated **31/03/2021**.




