- 1. Secretary, NEC in exercise of the financial powers delegated by the Govt. of India, Ministry of DoNER vide letter No. 4/1/2010-DoNER (NEC) dated 7<sup>th</sup> September, 2012 has accorded Administrative Approval for "Construction of Tourism Infrastructure at Laitlyngkot (Lamlyer) in East Khasi Hills District, Meghalaya" at an estimated cost of Rs. 465.00 lakhs (Rupees four crore sixty five lakh) only implemented by the Meghalaya Tourism Development Corporation Ltd. (MTDC Ltd.) to be funded by NEC under the scheme "Schemes of North Eastern Council" under MH-2552 OH-35.

- (i) The land on which this project will be constructed and the assets/facilities created out of this Government Grant will not be transferred/sold/alienated without the approval of NEC and Ministry of DoNER, Govt. of India. Meghalaya Tourism Development Corporation Ltd. shall ensure proper upkeep, maintenance and operation of the assets/facilities created out of the project.
- (ii) Proper monitoring of the project should be carried out by Meghalaya Tourism Development Corporation Ltd.
- (iii) The fund should be utilized only for the purpose for which it has been approved. No diversion of fund for any other purpose would be allowed.
- (iv) Meghalaya Tourism Development Corporation Ltd. shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provision of C&AG (DPC) Act, 1971 in accordance with the provisions laid down in Section 14 of the C&AG (DPC 1971) as amended from time to time and Internal Audit Party of the Principal Accounts Office of the (Ministry of DoNER), whenever it is called upon to do so.
- (v) Meghalaya Tourism Development Corporation Ltd. shall adhere to all the relevant provisions of GFR 2017 and any other instructions/guidelines issued by the Government from time to time, while making procurement/purchases of goods and services including compliance to GFR provisions in case of out-sourcing of services and engagement of consultants.
- (vi) In no case the grant released under this sanction will be utilized for any purpose other than those indicated in the sanction. The grantee shall not divert the grants and entrust execution of the Scheme or work concerned to another Institution or Organization and shall abide by the terms & conditions of the grant and follow/adhere to all the relevant provisions of GFR regarding Grants-in-aid. If the grantee fails to utilize the grant for the purpose for which the same has been sanctioned or does not adhere to the terms & conditions of Grant and GFR provisions, the grantee/Institution shall be required to refund the grant with interest @ 10% per annum.
- (vii) The grantee institution shall not utilize the interest earned on the recurring/non-recurring grant-in-aid released to the institution for any purpose. The interest earned shall be refunded to GOI after grants-in-aid sanctioned is utilized in terms of Rule 230(8) of GFR 2017.
- 3. Fund sanctioned under this project shall be released in favor **Meghalaya Tourism Development Corporation Ltd.** and the fund should be specifically used for implementation of the project only.
- 4. It is certified that all Utilization Certificate (UCs) due for rendition have been submitted by **Meghalaya Tourism Development Corporation Ltd.** for all of the schemes/programmes/projects of the Ministry/Department and no Utilization Certificates (UCs) is pending for the previous years/periods against **Meghalaya Tourism Development Corporation Ltd.**
- 5. The project is approved under the 60% Central Component of the outlay allocated for Schemes of NEC for the year 2022-23.
