- Put in place strategies for identification and documentation of Community driven innovations.

4. Commission studies, appoint teams to search and scout for innovative practices, within and outside the State.

5. Approve strategies for propagation and improvement of innovative traditional knowledge,

technological and other innovations supporting natural resource based interventions etc.

6. Scrutinize, approve and recommend for sanction, proposals submitted by individuals, groups

of individuals, institutions and NGOs.

7. Recommend a mechanism for monitoring and evaluation to ensure that Innovations are

carried out in with due diligence and efficiency and in accordance with sound technical,

financial, environmental and managerial standards, including the Anti-Corruption
