No. PLR. 147/2013/89 : The Governor of Meghalaya is pleased to State that Dr. Subhash Ashutosh, the **Co – Chairman and Director** of Centre of Excellence (CoE), Meghalaya Institute of Natural Resources, Meghalaya (MINR) will draw remuneration and facilities, etc. as follows :-

- (a) **Remuneration** – He shall be entitled to monthly remuneration equal to the last pay and allowances while in service under the State Government and shall be reduced by the amount of pension (Basic Pension + DA + MA) which the Co-Chairman received for service under the State Government.
- (b) **Pre-requisite** – The **Co – Chairman and Director** shall be entitled to the following facilities:-
 - i) POL – 200 litres of petrol and 4 litres of mobil oil.
 - ii) House Rent allowances - as admissible.
 - iii) 1 (one) Personal Secretary.
 - iv) 1 (one) office peon and 1 (one) bungalow peon.
 - v) 2 (two) newspapers and 2 (two) magazines.
 - vi) 1 (One) vehicle with driver.
 - vii) Mobile phone charges re-imbursement as admissible.
- (c) **TA/DA** – The Co-Chairman shall be entitled to TA / DA as per the entitled class on the date of his retirement while travelling within and outside the State.
- (d) **Office space** – to be arrange by the office of the Centre of Excellence (CoE), Meghalaya Institute of Natural Resources (MINR).
